3. That the proposed expenditure shall be incurred by the Principals of Govt. Colleges.
4. That the budget may be utilized by **28th February, 2017** & send detailed B.M. 26/29 giving details category wise up-to-date.
5. That the mode of payment will be as per Govt. rules.
6. That the institutional heads shall be responsible to ensure the implementation of the scheme in letter and spirit. Any deviation from rules/instructions/policy will be viewed seriously and they would be held personally responsible for the lapse.
7. **DDO (Principal) to ensure that the payment of LTC/Medical reimbursement is in accordance with the Govt. Rules. If any wrong payment is found the DDO (Principal) will be held responsible personally for the same.**
