Consequent upon the decision taken by the Haryana Govt. vide Notification No. 6/7/2014-1G.S.I dated 18.06.2014 and Amendment dated 22.08.2014 to regularize the services of Group C and Group D employees engaged on contract basis/adhoc/work charges/daily wages or engaged by the Govt. through approved agency of the State Government who have worked for not less than 3 (three) years as on 28.05.2014 and also still in service on 28.05.2014. The following official is hereby offered appointment as Laboratory Attendant in an officiating capacity as per provisions contained in the "Haryana Education Department (Sub Offices College Cadre (Group-C) Services) " as amended from time to time in the pay band of Rs.5200-20200+1900 G.P. plus usual allowances as sanctioned by the Haryana Government from time to time and are hereby posted at the present place of posting i.e. Govt. Colleges :-

Terms and Condition:-

1. He is appointed purely on temporary / provisional basis.
2. His appointment is against temporary posts and his confirmation against substantive posts shall be considered on the basis of his seniority and record of service as and when such post is available.
3. If at any stage, he desire to resign from his post, he will be required to give one month's notice or forfeit in lieu thereof his salary including allowances for one month or for the period by which the notice falls short of one month. The Directorate will give such a notice to him also in case it is proposed to terminate his service for the reasons other than who mentioned in clause (1) above.
4. He will remain on probation for a period of two years from the date of joining in the Department. The period of probation can be extended in accordance with the existing rules. For assessing their performance during the period of probation, his work and conduct will be taken into consideration.
5. He will be required to take the prescribed oath of allegiance to the Constitution of India.
6. In case he is married, he will produce the certificate that he is not having more than one living spouse.
7. In case he is unmarried, he will have to furnish a declaration to the effect that he is unmarried till the date of joining the duty.

8. He has to furnish a Medical Fitness Certificate from the Concerned Chief Medical Officer as required under Rule 3.1 of the Punjab CSR Vol.I,Part-I.
9. If he has not been vaccinated within last twelve months, he should vaccinate before joining the duty.
10. He will not undertake higher studies of any kind without prior permission of the competent authority. Consequently, no leave of any kind will be granted for the prosecution of higher studies.
11. His application, if any, for employment outside the Deptt. shall not be forwarded for a period of five years from the date of his joining the Department. He will, however, be permitted to sit in a competitive examination once a year only. Such a permission shall be given on the express condition that the study and preparation for the competitive examination will in no way interfere the discharge of his normal duties and he will not be allowed any leave for the purpose.
12. He will be required to produce the original educational documents pertaining to his qualification, experience, age and caste/category, as claimed by him in application form & others before joining his duties.
13. No TA/DA or joining time will be allowed to him for joining this post.
14. His services will be governed by Haryana Educational College Cadre (Group C) Service Rule-1986.
15. His seniority will be fixed in accordance with the Departmental Rules.
16. He will be covered by the New Pension Scheme-2009 of the Haryana Government.
