Subject Increase in remuneration of Guest Lecturers and Lecturers engaged on Extension Lecture Basis working in the Govt. Colleges of the State.

Kindly refer to the subject cited above.

The State Government has decided to increase the remuneration of guest lecturers and lecturers engaged on extension lecture basis in the Government Colleges of the State **with effect from 01.04.2014** as per detail given below:-

FOR GUEST LECTURERS :

<p>NET/SLET shall remain the minimum eligibility condition for recruitment and appointment as lecturer in Colleges. Provided, that candidates, who are or have been awarded Ph.D. degree in compliance of the UGC (minimum standards and procedure for award of Ph.D. degree), Regulation 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET for recruitment and appointment of lecturer/Assistant Professor or equivalent position in Colleges. Provided further that the candidate who have acquired Ph.D. Degree upto 31.5.2009 shall also be exempted from the requirement of the minimum eligibility conditions of NET/SLET for recruitment and appointment to the posts of lecturer or equivalent positions in colleges. Provided further that those candidates who have been enrolled for Ph.D. upto 31.5.2009 shall become eligible for exemption from the requirement of the minimum eligibility condition of NET/SLET for recruitment and appointment to the posts of lecturer or equivalent position in Colleges only on acquisition of Ph.D. degree.
